Hello Co-op Community! This month we had the opportunity to attend the Consumer Cooperative

Management Association Conference in Sacramento, California. This conference is put on every year by the University of Wisconsin Center for Cooperatives. Representatives from food cooperatives all over the United States were there. The theme for this year was Reconnection and Resilience.

The conference is where cooperative "celebrities" come to share knowledge, educate the next generation, provide inspiration and make connections. It was inspiring indeed! The conference began with chosen tours. I chose to tour the brand new Briar Patch Cooperative building.

Briar Patch opened a second store 25 miles away from their original store. It was very neat to see a brand new, open floor concept co-op. One of the coolest choices they made was to use CO2 systems for all refrigeration. These systems use less hydrogen, fluorine and carbon refrigerants greatly reducing the risks of leaks harmful to the environment.

The next two days were filled with keynote speakers and breakout sessions. One keynote speaker was

Errol Schwiezer who was very knowledgeable on all things Co-op. He gave a presentation called "*The Future of Grocery: How Co-ops can Adapt and Compete.*" The presentation was filled with information from how modern grocery stores were created, to monopolization, to worker unions, principles of degrowth and more. He was an excellent presenter and worth checking out online. He has articles in Forbes and a podcast called "The Checkout Podcast."

One of my favorite parts of the conference was attending a roundtable discussion of Board Presidents. There were twelve Board Presidents from Atlanta, Montana, California, and more. Being President of the Board is a unique position. As written in our policies, "the president's job is to ensure the integrity of its process, so that the Board behaves consistently with its own rules, the bylaws, and legal requirements." It was comforting to hear from others about their challenges and have the opportunity to share information.

I went to very interesting breakout sessions. I heard from a group of general managers and what it was like to go through the hiring process with a Board of Directors.

I learned about an expansion project and capital campaign from a Co-op in Maine that raised \$1.5 million in loans from its owners. I leaned about how communities are using the cooperative model to bring food to their communities that have

**How does it work?** At checkout, you're entitled to one Bean token for every reusable bag or box used to pack-up your groceries. Grab your tokens from the cup kept at every register and use them to vote at the Bean Towers next to each exit on your way out.

Each quarter, we update these towers to highlight the current quartet of non-profit organizations. Below the name of each organization—and some info about them—is a jar for collecting your Bean tokens. Drop your tokens into the jar (or jars) of your choosing. At the end of each quarter, we count-up all the tokens and use them to determine the proportion of the quarterly \$1,000 donation each organization receives.
